

STYLDOD TERMS OF USE

Welcome to Styldod! Styldod is an online platform dedicated to home improvement and design. We provide interior design services that allow its Clients to visualise beautiful furniture, furnishings and decors within the context of their own homes/spaces. Through Styldod, people can find or offer design ideas, advice, products and services related to home renovation and design. Users can view and edit their home designs in our proprietary software.

These Terms of Use (the "**Terms**" or the "**Agreement**") set forth the binding legal agreement between you and Eazyhomez designs and decors pvt ltd.. The Agreement governs your use of www.styldod.com and all of the related websites, products and services offered by Styldod, including our 3D plug-ins and browser extensions (collectively, the "**Styldod Platform**").

We encourage you to review this Agreement carefully. By accessing or using the Styldod Platform in any way, you are agreeing to these Terms in their entirety. If you do not agree to any of the Terms, you may not use the Styldod Platform.

1. Description of Services

Styldod provides online interior design services that allow its clients to see trending designs and decors within the context of their own homes. Styldod helps homeowners, remodelers, renters and virtual staggers in creating personalized designs online.

As more fully described on the Site, Styldod offers the following Services:

1. Helps users understand their requirements in more detail.
2. Helps users to discover their personal interior design style tastes, color theme and preferences.
3. Provides specific, personalized interior design ideas and advice based on room photos that users submit to Styldod.
4. Allows users to view and edit their room designs in 3D environment.
5. Allows users to shop for home furnishings based upon their design preferences.

2. Using the Styldod Platform.

Who can use it. You must be at least the age of majority in the state where you live to use the Styldod Platform. Use of the Styldod Platform by anyone under 16 years of age is strictly prohibited!
